

- **Resident tag fee for registration permits on Nunivak would be \$25 for bulls and cows
- **Resident tag fee for draw permits on Nunivak would be \$500 for bulls
- **Nonresident tag fee for registration permits on Nunivak would be \$1100 (\$1500 alien)

> 1967-1968 23 Muskox were transplanted from Nunivak Island to Nelson Island.


> 1975 First hunting on Nunivak Island.

> 1981 First hunting on Nelson Island.


2013 Currently, 150-200 muskox on mainland.





Nunivak Island Short-Term Management

Department short term goals for Nunivak Island population:

- 1. Bring population up to 500 550 post-hunt pre-calving through harvest management (reduced harvests)
- 2. Temporary decrease in harvest anticipated for next 3 years
- 3. Maintain bull:cow ratios at 80:100
- Regulatory year 2014-2015 anticipated harvest:
 30 bulls and 5 cows
- 4. When population is within objectives (500 550), resume harvesting at a minimum of 10% of population (50-55 musk ox)
- 5. Update the cooperative management plan for Nunivak Island

(5) musk oxen: the harvest of musk oxen in Unit 18 Nunivak Island shall be managed by a combination of registration and drawing permit hunts, as follows:

- i. up to 10 drawing permits may be issued for the fall season hunt;
- ii. up to 100 drawing permits may be issued for the spring season hunt;
- iii. up to 60 registration permits may be issued on a first-come, first-served basis; the permits may be issued for fall hunts or spring hunts;
