



- · Use the cooperative management plans for Nelson Island.








#### **Nelson Island Short-Term Management**

Department short term goals for Nelson Island population:

- 1. Bring population down to less than 450, but more than 250 musk ox in next three or four regulatory years.
- 2. Temporary increase in harvest anticipated for next 3 or 4 years
- 3. Regulatory year 2014-2015 anticipated harvest: 100 cows and 50 bulls
- 4. When population is within objectives (250-450) resume harvesting at 10% (25-45 musk ox) of population.

- (4) musk oxen: the harvest of musk oxen in Unit 18 Nelson Island shall be managed by a combination of registration and drawing permit hunts based on the harvestable portion of the population, as follows:
  - i. if the harvestable portion is 40 or less musk oxen, only registration permits may be issued; permits will be issued on a first-come, first-served basis;
  - ii. if the harvestable portion is greater than 40 and but less than 61 musk oxen; 40
    registration permits shall be issued on a first-come, first-served basis; the remaining
    available permits shall be allocated 80% to on-line registration permits and 20% to drawing
    permits; up to 4 drawing permits may be issued; the total number of permits issued may
    be based on hunter success rates to achieve harvest quotas;
  - iii. if the harvestable portion is greater than 60 and but less than 71 musk oxen; 40
    registration permits shall be issued on a first-come, first-served basis; the remaining
    available permits shall be allocated to on-line registration permits and 5 drawing permits;
    the total number of permits issued may be based on hunter success rates to achieve
    harvest quotas;
  - iv. if the harvestable portion is greater than 70 musk oxen; 40 registration permits shall be issued on a first-come, first-served basis; the remaining available permits shall be allocated to on-line registration permits and 6 drawing permits; the total number of permits issued may be based on hunter success rates to achieve harvest quotas;
