SUBJECT: Comments in support of ACR #7 - August 7, 2015 Board Teleconference

Chairman Spraker and members of the Board of Game,

On behalf of our directors and over 600 members, we appreciate the opportunity to provide comments. We urge you to grant the ACR (#7) we filed asking the Board of Game to consider a proposal to *prohibit the take of wolves on certain lands in Unit 20, adjacent to Denali National Park* at its March 2016 meeting. With the ACR, we submitted a map of the area to be considered for closure. The map includes lands in the Stampede townships and along the Nenana Canyon formerly closed to the take of wolves by the Board of Game. We also submitted a draft proposal that we would like to be considered at the Board of Game's only 2016 regulatory meeting.

By request, we will confine our comments in support of this ACR to the criteria of acceptance as specified in 5 AAC 92.005.

a. Conservation purpose or reason – low numbers of wolves in Unit 20C

- Although natural cycling is expected in wolf populations, the numbers and densities of wolves in GMU 20C (which includes Denali National Park and lands north of the park extending as far as the Tanana River) have been low and in recent years below the Department of Fish and Game fall density objective of 11/1000 mi².
 - a. The Department's most recent survey of wolves in 20C outside Denali (2012) came up with a spring density of $4.1/1000 \,\mathrm{k^2} \,(10.7/1000 \mathrm{mi^2})$, just barely meeting the objective. *No data were collected for fall, but see NPS data in (b)*.
 - b. Denali National Park, which occupies a good third of GMU 20C, conducted spring and fall surveys in 2012, confirming similar low densities (3.8/1000k² in spring, 3.1/1000k² in fall). It is notable that there was no increase through pup population between spring and fall in 2012.
 - c. Although the Department of Fish and Game does not conduct regular wolf surveys in 20C and has not published wolf survey data for 20C since 2012, scientists at Denali National Park have collected data on NPS lands since the 1980s in both spring and fall. These data show that, since 2012, spring wolf numbers and densities have continued to decline and remain below 11/1000 mi². The most recent density estimate was in spring 2015, at 2.8 wolves/1000 k². In early summer 2015, the Denali National Park wolf population was 46.
 - d. Wolf population numbers in Unit 20C as a whole are likely to be similar to those reported for Denali National Park. In any case, the Department has no data to indicate that wolf densities in any part of 20C are greater than those provided by National Park researchers.
- ii. For us, the reduction of wolf numbers in Unit 20C is a conservation concern because numbers are not meeting Department objectives, given the data we have for 20C. We know that the Department has stated that the wolf population as a whole in GMU 20 is healthy. However, for us, a conservation concern does not require a "unit-wide or population level" drop, but can exist at the subunit level. We note that other ACRs introduced for this teleconference deal with subunit conservation issues.



iii. For us, this subunit-level conservation concern is about what many Alaskans value and want to retain in Denali National Park – the opportunity to view and study wolves in a relatively undisturbed predator-prey system, and the wish of many Alaskans that the Board of Game will support that opportunity. For many Alaskans this is about conserving a certain collection of wolves that den inside the park. Yes, there is dispersal but there are also known groupings of wolves that have historically used Denali National Park for denning and that attract visitors from around the world.

b. To correct an error in regulation N/A

c. To correct the effect on a hunt that was unforeseen when a regulation was adopted.

- i. The Director of the Division of Wildlife Conservation has already stated in his comments on ACR #7 that changes in bear hunting regulations (allowing the take of brown bears at black bear bait stations) promulgated by the Board in 2012 had the unforeseen effect of bringing more hunters into the field during the spring bear baiting season, at a time when wolf hunting season is still open. During the most recent season, when there were bait stations on state lands just outside the National Park, wolves visited one of the stations and two East Fork pack wolves were killed. We agree that the presence of hunters and bait stations created an unforeseen effect on wolf take in the spring, during a time when wolves take predictable extraterritorial forays outside Denali Park. This situation was made even more critical by the placement of the East Fork den close to the park boundary and bait stations. Additionally, these wolves had the potential to be most viewed by park visitors, through the placement of their den. The board should have the opportunity to consider this new information at its earliest opportunity, which would be March 2016.
- ii. Finally, when in 2010 the Board of Game instituted a five-year moratorium on consideration of "no wolf take" proposals for state lands adjacent to Denali National Park, the Board itself had the expectation that an Interior Region Board of Game Meeting would occur in 2016, and set the moratorium to expire in time for that meeting. However, in January 2015 the Board of Game changed the cycle of its meetings, with the result that the next Interior Region Board of Game Meeting was moved to 2017, creating the unforeseen consequence of increasing the moratorium from five to six years. Since 2010, the National Park Service has conducted studies on the effect of breeder loss and the effect of hunting/trapping closures on viewability of park wolves, studies that were an effort to address concerns the Board of Game brought up in 2010. These studies are now complete or in review. Alaskans who consider this issue important expected that the Board would convene to hear new data on this issue in 2016. We ask that you make that possible by granting ACR#7.

Dear members of the Board of Game,

Thank you for considering the Agenda Change Request (ACR #7) to include a Denali Wolf Buffer proposal at the March 2016 Statewide meeting. The National Parks Conservation Association (NPCA) supports ACR#7 and urges you to accept this request for the following reasons:

- 1. The six year moratorium imposed in 2010 will have expired.
- 2. In spring 2015 the population of Denali park wolves has dropped to the lowest recorded level (just 48 individuals) since surveys began in 1986.
- 3. From 2010 to 2014 the number of park visitors seeing wolves declined from 45% to 6%.
- 4. Unlike mortality from natural causes, wolf hunting and trapping frequently takes the alpha individuals. Loss of the pack leaders often causes disruption and dispersal of the entire pack and results in a decline of wolf viewing, as what happened with the Grant Creek pack in 2012.
- 5. The State Constitution (Article VIII) requires wildlife be managed "for maximum use consistent with public interest." The public interest includes both hunting AND wildlife viewing.
- 6. ANILCA added the northern additions to Denali because it is "critical range necessary to support populations of moose, wolf, and caribou as part of an integral ecosystem" and that the Wolf Townships "are important to the park and recommends that the Secretary seek land exchanges with the State of Alaska that would serve to bring these areas into the Park". (Senate report 96-413, 1980, pages 166-167)
- 7. Tourism is vital to Alaska's economy and Denali is one of the state's top tourism destinations. Denali visitors contribute over \$500 million dollars to the local gateway economy the third highest of any park in the nation.

Dear Board Members -

As a former resident of Alaska who lived & worked at Denali National Park, and someone who continues to bring visitors to the state for wildlife viewing purposes, I am deeply concerned about this issue. So much so, that I am writing to you while on business overseas. I urge the ADFG to grant ACR #7 (the Denali wold buffer zone) for the following reasons:

- 1. **Public policy:** The moratorium on consideration of wolf buffers from 2010 to 2016 was not good public policy. Adding another year onto this moratorium, in a climate of intense public interest, disrespects public discourse. The Board of Game's 2010 decision clearly stated the moratorium was for a six-year period, which at that time coincided with the 2016 Interior Region meeting. It was disconcerting to have had the interior region meeting delayed. The Board's recent decision to change its meeting schedule, thereby delaying the next Interior Region meeting to 2017, is not a valid reason for lengthening the moratorium to seven years. This was not the intent of the Board's 2010 decision.
- 2. **Public policy:** A viewability study specifically requested by the Board of Game has recently been completed. The Board of Game should hear the results of this study as soon as possible, since it was the Board of Game that asked for the study.
- 3. **Conservation**: The overall population health of wolves in GMU 20 does not mean that a subunit-level conservation issue does not exist. We do not understand the Department's insistence on a region-wide interpretation of population health here. The data from GMU 20C are not indicative of wolf population health.
- 4. Impact of hunting/trapping: The fact that habitat and prey may be limiting numbers of wolves in 20C to densities near the lower management limit argues for considering stressors that can be controlled, such as hunting and trapping.
- 5. **Impact of hunting/trapping**: Although, from the numbers standpoint, human harvest of wolves in areas northeast of Denali National Park is low, the loss of just one wolf can disrupt the pack, if breeders are taken. This has been shown in a recent study. Since hunting season moves through the entire breeding season and into the denning season, breeders can be and have been taken. Additionally, this ACR is intended to correct an unforeseen consequence of an earlier Board action, and therefore meets the Board's own criteria for approval of an ACR. After the Board extended the season for bear-baiting stations adjacent to the boundary, at least one radiocollared wolf from the Park was attracted to a bait station and shot by a hunter. This increased opportunity to harvest wolves is clearly an unforeseen and unintended consequence of the Board's changes to the bear-baiting regulations.

I urge you to please vote "yes" to approve ACR #7.

As others have pointed out, this ACR is intended to correct or address an unforeseen consequence of a Board action (namely its approval of brown bear baiting in the area adjacent to Denali Park, which has resulted in the unexpected kills of wolves). It thus meets the Board's own criteria to approve an ACR. It would also take into account changing circumstances (the new schedule) which weren't anticipated in 2010. I am concerned about notable decline in the number of wolf sightings in Denali National Park and Preserve due, in part, to hunting and trapping outside the Park's boundaries. In addition to the important function wolves play in maintaining ecosystem health, financial estimates show Denali tourism contributes over a \$140 million a year to Alaska's economy. In fact, according to a report from the Anchorage and Juneau based McDowell Group, wildlife viewing was one of the most popular activities for tourists visiting Alaska; those who traveled to Interior Alaska and Denali were more likely to look for wildlife – including wolves.

Recently, Denali's wolves got a brief reprieve when Alaska closed hunting and trapping along the park boundaries two weeks early. But the killing resumes in August, 2015.

Thus, I respectfully urge Governor Walker, Alaska Board of Fish and Game, and the representatives of the National Park Service to reinstate May's emergency closure so that state and federal officials can finally negotiate a permanent conservation easement that will protect Denali's wolves for future generations. Chairman Spraker and members of the Board of Game,

I am writing to express support for the Agenda Change Request #7 submitted by the Denali Citizens Council and Alaska Wildlife Alliance. I live on Stampede Road, near the previous closure. While I am not opposed to hunting and trapping, I feel strongly that the nonconsumptive uses of this particular wolf population is valuable to more people, and to our local economy (which is highly dependent on tourism income) than the consumptive uses. While this allocation issue is lurking in the background, I understand that in order to consider an ACR, other criteria are considered. Turge you to approve this ACR for the following reasons:

- Conservation Concern: While the Board has maintained that there is not a conservation issue in the whole of GMU 20, wolf population density in 20C is below the Department of Fish and Game's own management criteria (see "Species Management Report ADF&G/DWC/SMR-2012-4"). The Board of Game has an opportunity to address this by reinstituting the closed area.
- Address unexpected consequences of new regulations: Bear baiting was uncommon in this area previously, as there are relatively few black bears. At least one hunter, most likely targeting brown bears, which are much more common in this area, has now established a bait station here. When the Board approved allowing the take of brown bears at black bear bait stations, I do not think it anticipated that this would lead to more hunters in the field in the spring, and the unforeseen consequences for the local wolf population.

When the Board decided not to renew the closure on Stampede and along the Nenana River corridor, you asked for research showing how or whether the closure impacted wolf viewing opportunities in Denali. This research now exists, and suggests that when the closure was in place, both wolf harvest on state lands and wolf viewing opportunities in the park were at higher levels when compared to when the closure was not in place. I hope that the Board is following this research to help inform your decisions, and encourage you to invite the primary researcher, NPS biologist Bridget Borg, to present her findings to you.

Reason for Change: A Conservation Concern

Recent changes in Board of Game process have bumped the 2016 Interior Region meeting to 2017, making it almost two years before this critical issue can be addressed in a normal Board of Game process. Therefore I am requesting an agenda change which will allow a full discussion of the buffer zone before 2017.

Whv:

- 1. **Public policy:** The moratorium on consideration of wolf buffers from 2010 to 2016 was not good public policy. Adding another year onto this moratorium, in a climate of intense public interest, disrespects public discourse. The Board of Game specifically requested a study about this issue, which was completed, and the results should be reviewed as soon as possible for making science-based decisions.
- 2. **Conservation:** The overall population health of wolves in GMU 20 does not mean that a subunit-level conservation issue does not exist. The Department should reconsider making a region-wide interpretation of population health. The data from GMU 20C are not indicative of the overall wolf population health.
- **3. Impact of hunting/trapping, part 1:** The fact that habitat and prey may be limiting numbers of wolves in 20C to densities near the lower management limit argues for considering stressors that can be controlled, such as hunting and trapping.
- **4. Impact of hunting/trapping, part 2:** Although, from the numbers standpoint, human harvest of wolves in areas northeast of Denali National Park is low, the loss of just one wolf can disrupt the pack, if breeders are taken. This has been shown in a recent study. Since hunting season moves through the entire breeding season and into the denning season, breeders can be and have been taken. **Conclusion:** Because of these four factors, this discussion should not wait till 2017. I urge you to allow an agenda change request for discussion of a no-take wolf buffer zone in 2016.

As a former employee in Denali Canyon (summer 2014), I spoke with visitors to DNP from ALL over the world (during a four month period) asking them about their park experience and what wildlife, if any, they saw - and out of many thousands of people, only a HANDFUL of them said they saw a wolf! (I, myself, took bus rides into the park regularly and never saw one all summer). And of the tourists I spoke with, many, many of them came to Denali specifically hoping to see wild wolves, primarily because DNP is one of the LAST places on earth that tourists can see them. Consequently, they were extremely disappointed. Many tourists were also educated (via the Murie Science and Learning Ctr talks) about some of the reasons wolves are at such an all time low and how the families of wolves have been disrupted and scattered...i.e., the harvesting of wolves outside park boundaries....which I believe led to their disillusionment of DNP in general. As a result, I believe the lack of wolf sightings potentially decreased tourism revenue but also may have led to a decreased positive public perception of Denali National Park and it's surrounding land and people. I would think the state of Alaska would want to protect - AS MUCH AS POSSIBLE - the biological, pristine environment that Denali is and support any measure that contributes to the INCREASE of animals in the park as well as maintain the limited footprint on the environment, specifically because it's one of the world's gems. MANY people view wolves as a symbol of wild places, much of which we have lost in out society, and to be fortunate enough to see one in it's natural environment reinforces that those places still exist on earth. Alaska is a beacon in that regard, therefore, I strongly urge the state, the park service and the people of Alaska to SHARE the beauty of the area (and specifically DNP) with others around the world by DOING WHATEVER IT TAKES to preserve the land and animals for future generations.....instead of giving in to a few hunters/trappers that want to continue their way of life. When the Board placed a moratorium on the Denali wolf buffer zone from 2010 to 2016, many of us consider that they did it in secret. E-mailing among members, the Board avoided opportunity for the public to comment. The Board of Game was sued over that action and lost. The board must now provide opportunity for public comment.
- 2. Public Discourse on this issue should not be delayed any longer The Board deferred their 2016 interior region meeting until 2017. The 2016 meeting would have been the first time in five years, a buffer zone proposal could be considered. This is an issue of longstanding importance to Alaskans and to the tourism industry. Delay flies in the face of fairness to Alaskans.
- 3. Impact on Tourism An Alaskan for 47 years, I was interested in wolves long before I moved here. The thrill of my first view of wolves was in a visit to Denali. Today every wolf sighting in Denali is worth a fortune in tourism dollars.
- 4. Impact of hunting/trapping next to Denali Park. Research has proven that the loss of even one significant breeding individual wolf can cause significant consequences for wolf family groups and visitor viewing success. For instance, the alpha breeding female from the Park's Grant Creek family group was trapped on state lands in April 2012, leading to the group not denning or pupping, dispersing, declining from 15 members to only 3 that fall, and visitor viewing success in the Park dropping from 22% to 12% that summer. Due largely to the loss of this one animal, over 50,000 Park visitors were denied the rare opportunity to view wolves in the Park that summer. Grant ACR #7 (Denali Wolf buffer zone) for the following reasons -

- 1. **Public policy:** The moratorium on consideration of wolf buffers from 2010 to 2016 was not good public policy. Adding another year onto this moratorium, in a climate of intense public interest, disrespects public discourse.
 - (A large number of Alaskans are concerned about the Board of Game's avoidance of an issue that is important to them. Many of these Alaskans submitted comments on the recent Emergency Petition and the requests for Emergency Closure in May. It was truly an unforeseen change when the Board delayed an expected 2016 interior region meeting where, for the first time in five years, a buffer proposal could be heard.)
- Public policy: A viewability study specifically requested by the Board of Game has recently been completed. The Board of Game should hear the results of this study as soon as possible, since it was the Board of Game that asked for the study.
- 3. **Conservation**: The overall population health of wolves in GMU 20 does not mean that a subunit-level conservation issue does not exist. We do not understand the Department's insistence on a region-wide interpretation of population health here. The data from GMU 20C are not indicative of wolf population health.
- 4. **Impact of hunting/trapping:** The fact that habitat and prey may be limiting numbers of wolves in 20C to densities near the lower management limit argues for considering stressors that can be controlled, such as hunting and trapping.
- 5. **Impact of hunting/trapping**: Although, from the numbers standpoint, human harvest of wolves in areas northeast of Denali National Park is low, the loss of just one wolf can disrupt the pack, if breeders are taken. This has been shown in a recent study. Since hunting season moves through the entire breeding season and into the denning season, breeders can be and have been taken.

- (1) Yes, Approve ACR#7 (Agenda Change Request). The BOG's original decision had stated that the moratorium was for a six-year period which conincided with the 2016 Interior Region meeting. Changing your meeting schedule for the next Interior Region meeting to 2017 is not a valid reason for lengthening the moratorium to seven years.
- (2) This ACR is intended to correct an unforseen consequence of an earlier Board action, and thus meets the Board's own criteria for approval of an ACR. By the Board's extension of the season for bear-baiting stations adjacent to the boundary, already at least one radiocollared wolf was shot by a hunter because of the bear-baiting station. The Board's changes to the bear-baiting regulations hace plainly impacted the wolf population by increased harvesting.
