ALASKA BOARD OF GAME Arctic & Western Region Management Units 18, 22, 23, and 26A

(Game Management Units 18, 22, 23, and 26A) Bethel, Alaska January 6-9, 2017

MEETING SUMMARY

The Board of Game (board) convened the four day Arctic/Western Region meeting on Friday, January 6, 2017 at the Yupiit Piciryarait Cultural Center, in Bethel, Alaska. Six board members were present: Chairman Ted Spraker, Vice-chairman Nate Turner, Stosh Hoffman, Teresa Sager Albaugh, Dave Brown, Karen Linnell.) The seventh seat was vacant during this meeting.

Following introductions and ethics disclosure statements, the board listened to oral reports from agency representatives (see list of oral reports in Record Copy (RC) 1). Public testimony began Friday, January 6, 2017. The board heard from 33 testifiers (RC 37), 13 of which were advisory committee representatives. Deliberations on proposals began Monday morning.

The Board took action on 50 proposals, adopting 22, and deferring two to future meetings. Board Actions are recorded as: C = Carried; F = Failed; CA = Carried as Amended; NA = No Action; and D = Deferred. Regional/Multiple Unit Proposals

- <u>F</u> 1 Evaluate a separate amount reasonably necessary for subsistence for the Teshekpuk caribou herd
- C 2 Modify the hunt structure of the Western Arctic and Teshekpuk caribou herds
- F 3 Remove the exception to harvest tickets and reports for caribou
- F 4 Institute no-fly zones for caribou hunting in Units 21D, 22, 23, 24, & 26A
- <u>CA</u> 157 Set a customary and traditional (C&T) use finding, and establish seasons and bag limits for Emperor geese. The board established a positive C&T use finding for migratory birds including tundra swans for Units 18, 22, 23, and 26A, and a positive finding for C&T use for Emperor Geese Statewide. The board adopted resident registration hunts with individual area quotas and reporting requirements for Units 8, 9, 10, 17, 18, 22, and 23 and a nonresident drawing hunt in Units 8, 9, and 10 with an allocation of 25

- tags. The board requested a proposal to address C&T a finding for migratory birds statewide be submitted for the next Statewide Regulations meeting.
- <u>F</u> 5 Change "general season" to "subsistence" for Arctic/Western Region black bear hunts having positive customary and traditional use findings
- <u>F</u> 6 Clarify the resident general and subsistence hunting seasons and the nonresident general hunting seasons for caribou in Interior/Northeast Arctic and the Arctic/Western Regions
- <u>F</u> 7 Clarify the resident general and subsistence hunting seasons and the nonresident general hunting seasons for Dall sheep in Unit 26A
- <u>F</u> 8 Prohibit nonresident hunting of any prey species under intensive management in the Arctic/Western Region until harvest and population objectives are met
- <u>F</u> 9 Establish a ten percent nonresident sheep permit allocation for the Arctic/Western Region

- <u>CA</u> 22 Open a winter nonresident hunting season for moose in Unit 18 remainder. *The board amended the proposal to set the bag limit as one antlerless moose.*
- <u>C</u> 23 Reauthorize the antlerless moose hunting seasons in the Remainder of Unit 18
- <u>C</u> 24 Allow the harvest of brown bear at bear bait stations in Unit 18. The board amended the proposal to remove the salvage requirement for edible meat and retained salvage of hide and skull.
- D 25 Open a nonresident draw hunt for caribou in Units 18 and 19. *The board deferred the proposal to the Central/Southwest meeting scheduled for February 2018.*

- <u>C</u> 40 Increase the resident bag limit for brown bear in Unit 23
- NA 41 Require a guide-client agreement to apply for a nonresident brown bear drawing permit in Unit 23. *The board took no action because the regulation is already in place.*
- <u>CA</u> 42 Allow the use of bait for black and brown bear hunting in Unit 23. The board amended the proposal to set the bear baiting season date as April 15 June 30. The board clarified their intent to allow both black and brown bears to be taken at bait sites the same day as flown, provide you are at least 300 feet from the airplane.
- F 43 Allow the use of snow machines to position and harvest brown bears and furbearers in Unit 23
- <u>CA</u> 44 Modify the area of the Noatak Controlled Use Area in Unit 23. *The board amended the proposal to change the boundary of the Noatak CUA to start at the mouth of the Agashashok River and end at the mouth of the Nimiuktuk River. (The board reconsidered this proposal at 7:49:33.)*
- <u>F</u> 45 Require big game hunting camps to be three miles apart within and near the Noatak Controlled Use Area

The board took the following actions under miscellaneous business: (Audio log 8:09:22)

The board approved findings (RC 35 as amended) providing recommendations to ADF&G during the January 2017 Arctic & Western Region meeting.

The board reviewed RC 14, draft changes to the Agenda Change Request policy submitted by ADF&G. The board requested it be scheduled for further discussion at the February 2017 meeting.

In response to a public request, the board added two regulations to the Call for Proposals for the 2017 Statewide Regulations meeting: 5 AAC 92.008, Harvest guideline levels; and 92.061. Special provisions for brown bear drawing permit hunts.

The board reviewed and gave consent to the written report by ADF&G to the legislature (RC 31) describing changes in allocations between residents and nonresident opportunity, as required of ADF&G per Alaska Statute 16.05.050(b).

The board discussed changing the location for the Central/Southwest Region meeting, from Wasilla to Dillingham. The board deferred the decision to the February 2017 meeting in Fairbanks, and requested information about venue and lodging for Dillingham be provided.

The meeting adjourned at approximately 7:46 p.m.
