These are accidents and anyone doing this on purpose would not be treated well, they also lose their luck when hunting. This proposal hinders on the people's ability to practice their culture.

#### **Proposal 54**

I oppose this proposal ABOG must implement Tier II for wildlife population when there is not enough harvestable surplus to provide a reasonable opportunity for all subsistence users of that population.

## Proposal #55

I do not support this proposal. Alaska Natives have clear and distinct differences in religious ceremonies versus celebratory ceremonies. Religious ceremonies are protected under the US and Alaska State laws to protect our freedoms

of religion. The practice of harvesting big game for potlatches is a honoring of the deceased this is not a practice that happens for all ceremonies.
