- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:
- \* Section 1. AS 16.05.256 is amended to read:
- Sec. 16.05.256. Nonresident and nonresident alien permits. Whenever it is necessary to restrict the taking of big game so that the opportunity for state residents to take big game can be reasonably satisfied in accordance with sustained yield principles, the Board of Game shall [MAY], through a permit system, limit the taking of big game by nonresidents and nonresident aliens to accomplish that purpose.
  - \* Sec. 2. This Act takes effect January 1, 2020.

- \* Section 1. AS 16.05.255 is amended by adding a new subsection to read:
- 4 (I) The Board of Game shall establish in regulations adopted under (a)(2) of
  5 this section a week-long early season opening in each hunting area for veterans who
  6 have received the Purple Heart medal and for veterans who are certified by the United
  7 States Department of Veterans Affairs as having incurred a 50 percent or greater
  8 disability rating during military service.
