Following opening remarks and introductions, the board held officer elections. The board re-elected Jerry Burnett as Chair and Stosh Hoffman as Vice-Chair.

- Big Game Commercial Services Board (BGCSB): Chair Burnett provided an update on the BGCSB (See Record Copy (RC) 2). Chair Burnett will continue to represent the Board of Game on the BGCSB per the membership requirements in Alaska Statute 08.54.591. (Audio log: 09:56:19)
- Joint Board of Fisheries and Game Committee: The board discussed the recommendation by Joint Board Committee of Fisheries and Game Committee for holding a Joint Board meeting in March 2024 (See RC1: Meeting Workbook, page 42). The board voted to schedule a Joint Board meeting March 25–29, 2024 in Anchorage and open the Call for Proposals to 5 AAC Chapters 96, 97 and 99, with a deadline of May 1, 2023. The board set a requirement that proposals requesting modification to or repeal of the existing nonsubsistence areas, or to establish new nonsubsistence areas, must address at least one of the 12 socioeconomic characteristics listed under Alaska Statute 16.05.258(c). Proposals failing to provide information related to at least of the 12 criteria will not be included in the proposal book for consideration by the Joint Board. (*Audio log: 10:25:21 AM*)

The Board assigned members Jake Fletcher, Lynn Keogh and Al Barrette to serve on the Joint Board Committee, with member Barrette designated as chair for the Board of Game committee members. (Audio log: 10:39:40)

- Wood Bison Working Group: Member Al Barrette updated the board about recent Wood Bison working group meetings. He informed the board there will be a new Wood Bison working group for the reintroduction of Wood Bison into the Minto Flats and Yukon Flats areas.
