I do not support the implementation of a minimum trap check period anywhere in Alaska. The primary basis for this position is that a requirement to check traps within a set time window could force a trapper to be out in hazardous weather conditions. If a trapper were facing a man-made deadline for checking traps, he could be faced with the severe cold of arctic winter or intense storms of coastal Alaska. These conditions (and others) could be life-threatening.

Another scenario could involve a trapper suffering from illness or injury. Facing an artificial deadline, the trapper could once again be forced to venture out under circumstances which could lead to further injury or even death.

In addition, low population densities of many furbearer species do not justify checking traps frequently. The number of animals caught under this scheme would not cover the trapper's expenses. Trappers must make a profit to justify the time and effort they invest. Trapping systems in Alaska have evolved over decades to be as efficient as possible. Trappers have learned that allowing several days to pass between trap checks allows for efficient harvest of the renewable fur resource.

A minimum trap check period would place an unnecessary burden on law-abiding trappers, with no benefit to the furbearer resources.

I am writing to express my strong opposition to Proposal 75, which seeks to authorize the hunting of bears and wolves from helicopters to protect moose populations in Unit 16. While I understand the desire to manage wildlife populations in a way that supports moose populations, this method of hunting is neither ethical nor sustainable, nor is it fiscally sound. Using helicopters to kill predators from the air disrupts the delicate balance of Alaska's ecosystems and sets a dangerous precedent for wildlife management.

First and foremost, from a purely fiscal standpoint, the proposal is a waste of valuable taxpayer resources. ADFG itself recognizes that "adoption of this proposal would result in significant costs to the department if department staff conduct control activities." By ADFG's own reporting on similar intensive management efforts to protect the Mulchatna caribou herd in 2024, "overlapping confidence intervals across these years suggest that the population could have been anywhere on the spectrum of values, and in fact could have been declining instead of growing. The harvest objective of 2,400–8,000 has not been met due to the close of the seasons for continued conservation concerns as the MCH has shown no appreciable population increase since at least 2017."

Basic principles of good stewardship of public funds require some evidence of return on investment, and if ADFG cannot credibly say that the IM activities have evidenced a modicum of success in other units, Proposal 75 is essentially placing hundreds of thousands of tax dollars on red or black on a roulette wheel, hoping for the best. Taxpayers deserve better.

Furthermore, hunting from helicopters introduces a significant ethical concern. It is a method of hunting that is neither fair nor humane. The aerial approach eliminates the possibility for the animals to flee or defend themselves, essentially rendering it a one-sided slaughter. This approach is at odds with the principles of ethical hunting, which emphasizes fair chase and respect for the natural behaviors of wildlife. It is vital that wildlife management efforts reflect our collective responsibility to treat animals with dignity and compassion, not as targets in an unfair and distressing manner. While I recognize that under Proposal 75, ADFG is proposing initially only to conduct IM activities on wolves, the statement by ADFG that "The department has no plans to activate bear control at this time" rings hollow. Proposal 75 would allow the department to flip a switch and begin IM activities on bears at a moment's notice without any scientific data to support such efforts.

Moreover, the impact of this practice on the broader ecosystem is cause for concern. Bears and wolves play an essential role in maintaining the health and stability of Alaska's ecosystems. As apex predators, they help regulate populations of other species and prevent overgrazing that could negatively affect vegetation. The removal of these predators from the landscape could result in unforeseen ecological consequences, potentially harming the very moose populations that the proposal intends to protect. It is important to consider the long-term consequences of such a drastic action, which could alter the natural order and have cascading effects on other wildlife.

Furthermore, the proposal fails to consider non-lethal alternatives for managing predator populations. Scientific research has demonstrated that there are more humane and effective ways to support moose populations, such as habitat restoration, addressing human-related disturbances, and implementing

targeted, localized management practices. This is to say nothing of focusing on poaching, which is not at all discussed in connection with Proposal 75. By ADFG's own reporting on IM activities in 2024 regarding authorized hunting of the Multchatna caribou herd, "We suspect the actual harvest is substantially higher than the reported harvest." But the reality is, ADFG has no firm data to indicate that either bears or wolves are the primary contributors to perceived declines in moose populations in Unit 16. By prioritizing non-lethal methods, we can promote a more balanced and sustainable approach to conservation, one that respects the integrity of the entire ecosystem while also considering the welfare of all species involved.

In conclusion, I urge the Alaska Board of Game to reject Proposal 75 and consider more ethical, and fiscally and ecologically sound methods for protecting moose populations. The use of helicopters to hunt bears and wolves is not only inhumane but also poses a serious risk to Alaska's natural environment. It is also fiscally unsound. We have a duty to protect all species, including apex predators, in a way that is both responsible and respectful. I respectfully ask that you reconsider this proposal and focus on more sustainable and humane wildlife management practices for the benefit of both the moose and Alaska's broader ecosystem.

Proposal 33 seeks to allow the same day airborne "take" (killing) of wolves and brown bears in Unit 17. Alaska Stat. § 16.05.783 says "A person may not shoot or assist in shooting a free-ranging wolf or wolverine the same day that a person has been airborne. However, the Board of Game may authorize a predator control program as part of a game management plan that involves airborne or same day airborne shooting if the board has determined based on information provided by the department"

Same day airborne killing violates fair chase methods and gives hunters an unfair advantage over their target species. ADFG is neutral on allowing same day airborne killing of brown bears and they oppose same day airborne killing of wolves in Unit 17.

#### Proposal 59 - OPPOSE

Proposal 59 asks for a longer wolf trapping season in Unit 11. The current season runs from November 10 – March 31, but the proposal asks for a new season extending from October 15 – April 30 in order to give people more time to kill more wolves. Traps are inhumane and inherently nonselective. They injure and kill countless nontarget animals annually, including endangered and threatened species and even family pets. Traps often injure people too when attempting to release a trapped animal. In their comments,

ADFG acknowledges that extending the trapping season poses a risk to non-target species but they support the proposal despite these risks.

Proposal 75 - OPPOSE

Proposal 75 seeks to add ADFG removal of wolves, brown bears, and black bears to Unit 16 Intensive Management Plan. This would allow allow department employees to conduct aerial, land and shoot, or ground-based killing of wolves and black bears and brown bears using state-owned, privately-owned, or chartered equipment, including helicopters, under AS 16.05.783. The state wants to decrease the wolf population in this are to 35-55 wolves and claim that 100 wolves must be killed annually, for several years, in order to reach this minimum. ADFG claims that there's low interest from hunters because a majority of the wolves in Unit 16 have lice (which results in poor pelt quality) and low interest from pilots because they can participate in same day airborne hunting in other units. Therefore, ADFG argues that they may need to kill wolves because there's declining interest from the general public.

#### Proposal 79 – OPPOSE

Proposal 79 requests an extension of the wolf trapping season by one month to April 30 in Unit 14A, to give trappers more time to kill wolves and to align the trapping season with neighboring units. In their comments, ADFG acknowledges that extending the trapping season poses a risk to non-target species but they support the proposal despite these risks.

I OPPOSE this proposal. It is short-sighted and will do NOTHING to protect other animals. Aerial hunting is cruel and inhumane as is the bait and slaughter that is suggested as well. There is usually political and financial maneuvering and interest behind such a proposal.

I suggest that the Mulchatna herd hunting be prohibited for several years. The greatest predator of this herd is people. Over killing and poaching happens all the time. Wildlife such as wolves and bears kill the weak, slow, and sick, or eat their remains after they have died of natural causes. This strengthens the herd. People on the other hand kill for greed, not because they need the food. Further there is very little meat on a caribou leading to people killing several and then several more. With modern conveniences, subsistence is not what it was 11,000 years ago, when it was an important part of the lives of people in the region.

Often animals are killed when someone gets on a snowmachine or in a boat or ATV and runs an animal to exhaustion then kill it for sport. Big game hunters kill for trophies not out of need. For example, the head of one my my favorite bears from McNeil River is on the wall of a hunter from Texas. Waterfalls was a beautiful bear, and many of us loved seeing that her in the wild. I'll attach a picture of one of my favorite cubs from Lake Clark NP and Preserve. I hope she gets to grow up and live a long life and when her life does end, I hope it is of natural causes.

Certainly, there may be other factors besides predation or hunting that affect the Mulchatna herd. However, I believe that in closing hunting of the Mauchatna herd for several years, it will begin to grow. You can still hire fixed wing aircraft and helicopters to monitor the herd and ensure that they are not being hunted.

I am writing in response to the recent proposals made by the Alaska Department of Fish and Game (ADFG). Many of these proposals would harm Alaska's wildlife and disrupt the natural balance of its ecosystems. Alaska is one of the last great wilderness areas in the United States, and people travel from all over the world to see its incredible animals in their natural habitats. These animals are worth far more alive than as trophies.

Encouraging overhunting may bring short-term profits, but it risks long-term devastation. Overhunting key species—like brown bears, caribou, and moose—will disrupt the food web and make it harder for all animals to survive. Tourists will stop coming if there are no animals to see, and ecosystems will struggle to recover. Protecting wildlife is better for Alaska's environment and economy in the long run.

Below, I have addressed each proposal in numerical order to explain why they are unsustainable and dangerous.

OPPOSE Proposal 1: Reauthorize the brown bear tag fee exemptions

Allowing hunters to kill bears without paying a fee reduces the money needed to protect wildlife and keep populations healthy. Bears reproduce slowly—only every 4 to 6 years—so overhunting could wipe them out. Protecting bears is better for Alaska's economy because tourists come to see them alive, not dead.

OPPOSE Proposal 2: Open two bear baiting seasons

Baiting bears with food teaches them to rely on human handouts, which makes them more likely to get into dangerous conflicts with people. It's not fair or natural to trick animals like this, and killing bears that are just trying to survive harms the entire ecosystem.

OPPOSE Proposal 3: Allow the use of cellular cameras for bear hunting over bait

Using high-tech cameras to hunt bears gives hunters an unfair advantage and disrupts wildlife by bringing too many people into sensitive habitats. This kind of hunting is more about gadgets than skill and puts too much pressure on bear populations that are already struggling.

OPPOSE Proposal 4: Establish general season, archery-only sheep hunts

Sheep are an important part of mountain ecosystems. Overhunting them would force predators like bears to find food elsewhere, which can lead to more conflicts with humans. It's better to let nature manage itself than to risk upsetting the balance.

OPPOSE Proposal 5: Reduce the nonresident bag limit for caribou

While limiting caribou hunting seems like a good idea, it could make hunters shift their focus to other animals, like bears or moose. Caribou can have babies every year, but bears reproduce much more slowly, so we need to protect them more.

OPPOSE Proposal 6: Shorten the nonresident caribou hunting season

Shortening the hunting season might reduce pressure on caribou, but it could increase hunting of other animals, like bears, which are already at risk.

OPPOSE Proposal 7: Extend the caribou hunting season

Extending the hunting season disturbs not only caribou but also the bears and wolves that rely on them for food. This hurts the entire ecosystem and makes it harder for wildlife to recover.

OPPOSE Proposal 8: Clarify hunting feral reindeer on Umnak Island

Even though reindeer aren't native, allowing hunting could disturb the island's natural balance. The ecosystem is better off if nature is left to manage itself.

OPPOSE Proposal 9: Lengthen spring and fall brown bear hunting seasons in Unit 9

Lengthening bear hunting seasons puts too much pressure on bears, which take years to recover because they reproduce so slowly. Bears are crucial for the ecosystem, and overhunting them could cause longterm harm.

Support with Amendment Proposal 10: Close Unit 9A to nonresident brown bear hunting

Closing Unit 9A to nonresident hunters is a good start, but stopping all brown bear hunting would be even better. Bears need protection to keep their population stable.

OPPOSE Proposal 11: Shorten spring and fall brown bear hunting seasons in Unit 9C

Shortening hunting seasons is a positive step, but hunting during critical times—like when bears are getting ready for hibernation—should be stopped entirely to protect cubs and the overall population.

OPPOSE Proposal 12: Lengthen fall brown bear hunting seasons in Units 9D and 9E

Extending the hunting season would overburden bear populations, which can't recover quickly due to their slow reproduction rate. This proposal risks wiping out bears in these areas.

OPPOSE Proposal 13: Lengthen fall brown bear hunting seasons in Units 9D and 9E for residents and nonresidents

Lengthening hunting seasons for everyone would lead to even more overhunting and put bears at greater risk. This harms not only bears but the entire ecosystem they support.

OPPOSE Proposal 14: Lengthen fall brown bear hunting seasons in Units 9D and 9E for residents and nonresidents

This proposal repeats the problem of overhunting, which can devastate bear populations and destabilize the environment.

OPPOSE Proposal 15: Lengthen nonresident spring brown bear hunting season in Units 9D and 9E

Allowing more time for nonresidents to hunt bears adds extra pressure on populations that are already struggling. Tourists are more likely to visit to see live bears, not hunt them.

OPPOSE Proposal 16: Lengthen fall brown bear hunting seasons in Units 9D and 9E for residents and nonresidents

Expanding the fall hunting season would harm bear populations and hurt the ecosystems that depend on them, including other animals and even plants.

OPPOSE Proposal 17: Lengthen spring and fall brown bear hunting seasons in Unit 9E for residents and nonresidents

Lengthening both spring and fall seasons leaves bears no time to recover and puts cubs at risk. This could wipe out the population in the long term.

Support with Amendment Proposal 18: Shorten spring and fall brown bear hunting seasons in Unit 9C and convert to drawing permits

Shortening hunting seasons and requiring permits is a small improvement, but stopping bear hunting entirely would be much better for their survival and the ecosystem.

Support with Amendment Proposals 19-20: Hunting Arctic fox on the Pribilof Islands

Arctic foxes are key to controlling small animal populations. Overhunting them could lead to a boom in rodents, which would upset the balance of the ecosystem and cause more problems for other animals.

OPPOSE Proposal 21: Remove the two-per-day bag limit for beavers

Beavers create wetlands that many animals rely on, including bears. Overhunting them would destroy habitats and harm the entire ecosystem.

OPPOSE Proposals 22, 35–36: Shorten wolverine hunting and trapping seasons

Protecting wolverines is important because they help clean up the environment. If wolverines are overhunted, it would hurt the whole ecosystem and make life harder for animals like bears.

OPPOSE Proposal 23: Lengthen hunting season for Emperor geese

Emperor geese are an important part of coastal ecosystems. Overhunting them would harm scavengers and predators, including bears, that rely on these areas for food.

OPPOSE Proposal 24: Close the season for Alaska hares

Alaska hares are food for many predators. Protecting them helps keep the food web balanced and ensures survival for animals like bears and wolves.

OPPOSE Proposals 25-27: Various changes to moose hunting in Unit 17A

Hunting too many moose takes away a food source for predators like bears, which could force them into more conflicts with humans.

Support with Amendment Proposal 29 Caribou

OPPOSE Proposals 28, 30, 31: Caribou hunting restrictions in Units 9, 17, and 19

Limiting caribou hunting helps keep their populations stable, which also supports predators like bears and wolves.

OPPOSE Proposal 32: Allow year-round hunting of brown bears

This is one of the worst ideas. Bears can only reproduce every 4 to 6 years, so year-round hunting would quickly wipe them out and destroy the ecosystem.

OPPOSE Proposals 33-34: Allow airborne hunting of bears and wolves

Hunting animals from airplanes is unfair and unethical. It disrupts wildlife and could lead to population crashes that harm the whole environment.

OPPOSE Proposals 37-38: Changes to beaver hunting and sanctuary access

Allowing hunting in sanctuaries defeats their purpose and could destroy important habitats that support many species, including bears. Sanctuaries should be safe spaces for animals.

OPPOSE Proposals 39-45: Various changes to moose hunting in Unit 13

Hunting too many moose removes a key food source for bears and other predators, leading to ecosystem imbalance and possible conflicts with humans.

OPPOSE Proposals 46-50: Hunting caribou and sheep in Units 11 and 13

Caribou and sheep are critical prey for predators. Overhunting them forces bears and wolves to look elsewhere for food, upsetting nature's balance.

OPPOSE Proposals 51–56: Hunting sheep and goats

Hunting sheep and goats takes away food that predators like bears and wolves depend on. Letting these animals live naturally keeps the ecosystem balanced.

OPPOSE Proposal 57: Increase the bag limit for brown bears

Letting hunters kill more bears is a terrible idea. Bears already reproduce slowly, so overhunting could cause their numbers to crash and harm the entire ecosystem.

OPPOSE Proposals 58-59: Changes to wolf population management

Wolves keep small animal populations under control. Without them, rodents and other small mammals could overrun the area, causing even more problems.

OPPOSE Proposals 60-63: Changes to ptarmigan hunting

Ptarmigan are food for many predators, including bears. Overhunting them would disrupt the food web and make survival harder for larger animals.

OPPOSE Proposals 70 to 84: Expanding hunting and trapping seasons

Expanding hunting and trapping seasons puts too much pressure on wildlife and takes away resources from predators like bears. This harms the balance of the ecosystem and makes it harder for all animals to survive.

To: Alaska Department of Fish & Game Commissioner

I am writing to urge you to reject the latest plan from the Alaska Department of Fish & Game which would authorize gunners to utilize helicopters, snowmobiles, and other equipment to eliminate up to 80% of wolves, brown bears, and black bears across a 20,000-acre area. This area borders the Denali and Lake Clark National Parks and Preserves (Unit 16).

Under this plan, state agents would be authorized to shoot hundreds of animals on sight—as many as 80% of all wolves and black bears and 60% of all brown bears—on the doorstep of two national parks.

This operation is inhumane and represents a troubling approach to wildlife management. In addition, it lacks a scientific foundation as study after study shows that predators are not the major factor determining the population of moose, caribou, and other game animals. Alaska should protect and not disrupt the healthy predator/prey balance in the wild.

A similar Alaskan predator control operation in 2023 killed approximately 100 brown bears (including cubs) and black bears, far more than the original planners estimated. This suggests that the Department cannot control the true mortality levels during these exercises.

I strongly urge you to reconsider this senseless plan and prioritize a more balanced, humane approach to wildlife management.
