The Board of Fisheries met to review proposals for its Western Alaska regions including Chignik, Alaska Peninsula, Aleutian Islands, Bristol Bay, the Kuskokwim and Yukon Rivers, and the Arctic. It also tacked on a Statewide Finfish meeting and a hatchery committee meeting for good measure. The Board of Game met for Southeast and Southcentral, including Kodiak, Prince William Sound, the Kenai Peninsula and the Anchorage area.

Both boards closed the meeting season with a Joint Board meeting. Unlike most meetings where Boards Support facilitates the meeting by supporting board and AC members, the staff, and public, for the joint board meeting we were in the hotseat presenting proposals and answering questions for the board. We left the event with a profound respect for our colleagues in the department and all the effort AC members put forward. Sitting before the boards or an AC is daunting, and you have our sincere thanks for helping to advance Alaska's fish and game management.

Along the way this year, Boards Support received a great deal of help. Board of Game News

The Board of Game (BOG) acted on 152 proposal this cycle for the Southeast and Southcentral Regions, adopting a total of 78 including reauthorization proposals

> for antlerless moose hunts and brown tag fee exemptions.

Joint Board Meeting Wrap-Up

The Joint Board of Fisheries and Game met for the first time since October of 2013 this spring from March 21-23, 2019 in Anchorage. Ten AC members attended and provided public testimony. Many thanks to all of the ACs for helping to guide the Joint Board through the Uniform Rules of Operation regulations and other topics.

There were 40 proposals submitted, of which the board acted on 35, with 22 being adopted. A few highlights include some process changes, and there were also several proposals passed that changed AC memberships. Finally, some proposals passed to simplify, clarify, or better organize existing regulations. There's more info on changes of note on the reverse side of this sheet.

A number of strongly supported proposals failed, such as AC members sitting at the board table during deliberations. We encourage you to listen to the audio from the meeting to listen to the board members' concerns and reasons why they failed. Changes to Advisory Committee Membership

The Joint Board made adjustments to membership for six ACs:

- Central Kuskokwim AC gained two undesignated seats for a total of 12
- Lake Minchumina AC membership was reduced from 15 to nine
- Lake Iliamna AC reduced membership from Iliamna and Nondalton to one seat, added a designated seat from Port Alsworth, and gained an undesignated seat for a total of ten seats.
- Northern Seward Peninsula membership was reduced from 15 members to nine.
- Lower Kobuk AC was reduced from 15 members to 11.
- Noatak/Kivalina AC was reduced from 15 members to nine.

Other Changes of Interest

The Joint Board also adopted the following proposals:

- Proposal 11 consolidates the regulations addressing the creation of ACs.
- Proposal 15 changes the emergency closure process to exclude ACs that haven't met in the past 3 years... and allows notification to the commissioner by email instead of telegram.
- Proposal 16 expands AC functions to encourage involvement of youth and elders.
- Proposals 24 clarifies that AC meetings are subject to the Open Meetings Act.
- Proposal 27 removes the concept of "active" and "inactive" committees.
- Proposal 34 updates the joint board's petition policy to eliminate a contradiction with the subsistence proposal policy.

Abstentions Clarified to Count as Neutral Votes

Will of the majority of non-abstaining members to be the action of the committee

Proposal 23 was submitted by ADF&G to seek clarification for recording abstentions as part of the total vote count either as "no votes" or as neutral votes so as not to fall out of compliance with the quorum requirement.

The Joint Board amended Proposal 23 to clarify that abstentions shall only count as neutral votes. For example, an AC action having a vote tally of 7-6-2 means the motion carries 7-6 with two abstentions. Otherwise, abstentions could also be counted as "no votes" and the outcome of that same vote tally would fail by 7-8. When abstentions occur, ACs should be clear about the outcome of the vote. Further, ACs must state the reason for the abstention.

Joint Board Sets Five-Year Schedule Next meeting tentatively planned for 2024

The Joint Board agreed regulatory meetings should occur approximately every five years to consider regulations dealing with ACs and the process for adopting regulations (5 AAC Chapters 96 and 97). Subsistence use regulations (5 AAC Chapter 99) will be scheduled every ten years starting with the next Joint Board meeting, approximately 2024.

Clarification for Removing Members for Absences AC chairs able to announce vacancy after three consecutive unexcused absences

Removal for Cause due to absences was a subject addressed by Proposals 19 & 20, submitted by the Kenai Soldotna AC and ADF&G respectively. Current regulations gave authority to both the Joint Board and the AC chairperson which led to confusion. The Joint Board adopted Proposal 20 which repealed the Joint Board authority, confirming it is the duty of the chairperson when announcing a vacancy.





Election Procedures Updated

The regulations describing AC election procedures will be reorganized as the result of the Joint Board adopting Proposal 17. ADF&G put forth this proposal to reorder and combine provisions related to the election process and to remove redundant and vague regulations.

Adoption of Proposal 18 clarifies that the provision where ACs many not refuse membership to a nominee if there are vacancies applies only to "undesignated" seats.

Proposal 21 clarifies that the chairperson has the option to declare a vacancy for a seat for a member who has not been duly elected. Other regulations allow a member to remain in an expired seat until a successor has been elected. However, this has led to a number of members returning to a seat for years without an election occurring.
