

## NOTICE OF SPECIAL JOINT BOARD COMMITTEE MEETING OF THE ALASKA BOARDS OF GAME AND FISHERIES

The Alaska Board of Fisheries (BOF) and Board of Game (BOG) will convene a web conference special meeting of its Joint Board Committee (committee) at 1:00pm, Tuesday, January 19, 2021. The purpose of the meeting is to discuss current conditions related to COVID-19 and its impact on board meetings for the remainder of this meeting cycle and other regions currently out of cycle.

This is a non-regulatory meeting. The board will not take oral public testimony during the meeting. - if meetings are postponed what are the impacts on the public for the current and future cycles?
